Total Tax: A sustainable 5% tax structure (Buy: 2%, Sell: 3%) supports liquidity, reflections, burns, and impactful charity projects.

Global Impact: Initiatives funded through Riqavida align with the ecosystem's mission to create generational wealth while addressing water, housing, and education needs worldwide.

INTRODUCTION

Riqueza (\$RZA) is a trust fund cryptocurrency designed to build generational wealth. With its natural release model, RZA tokens are made available to everyone at a starting price of \$0.001. Through dynamic pricing, the token's value increases as demand grows, fostering fairness and rewarding early supporters. This innovative approach removes the need for pre-sales or exclusive phases, creating a transparent and sustainable ecosystem aligned with Riqueza's mission of transforming lives through financial empowerment and global impact.

VISION

To redefine generational wealth by building a decentralized, deflationary financial system that empowers individuals, strengthens communities, and fosters global progress.

CORE TOKENS: RZA AND RZX

RZA is the core asset of the Riqueza ecosystem, offering deflationary mechanics, long-term growth potential, and dynamic pricing. Unlike traditional cryptocurrencies that rely on exclusive pre-sales or early phases, RZA follows a natural release model. It starts at \$0.001 per token, and its price adjusts dynamically through the Automated Market Maker (AMM) curve as more tokens are purchased. This ensures inclusivity while fostering scarcity and rewarding long-term holders.

RIQUEZA (\$RZA): THE CORNERSTONE ASSET

02. RZA REFLECTIONS
